From the research and equipment used to identify, monitor and evaluate diseases, to the roads used to distribute commodities and carry patients in emergencies to the informal and formal health professionals delivering care, a good health system and infrastructure is often the difference between life and death in some communities. Accurate diagnostics is critical to successfully managing an infectious disease such as malaria. While diagnostic tools and protocols have become much better, there remains a challenge in the quality and coverage of malaria diagnosis in many countries across Africa, including Nigeria. This session spotlight will feature a case study presentation on Nigerian Breweries Plc and its Malaria Diagnosis efforts internally within its workplace. The spotlight will also highlight the challenges and implications for public health via Malaria Consortium's Support to Nigeria Malaria Programme (SuNMaP) and offer tangible ideas on how collaboration with the private sector can enhance capacity efforts in Nigeria.

CLOSING PLENARY: FINANCING FOR MALARIA TO MEET MDG 4 and 5 – BOOSTING INVESTMENTS LOCALLY

According to the 2013 World Malaria Report from the WHO, international funding for the disease has increased tremendously over the past decade from USD \$100 million in 2000 to USD \$2 billion in 2012. While significant progress has been made in large part due to these funds, more (innovative) financing approaches are required to achieve the USD \$5.1 billion per year needed to ensure universal access to life-saving interventions. During this high energy plenary, participants will hear how close we are to securing the necessary financing needed to eliminate malaria, what innovative mechanisms are being explored to meet the demands, where the private sector can and should take a leadership role, and what will be required of governments to boost local financing for health programs.
