Members of the PSD serve an essential role in shaping Global Fund strategy and have the opportunity to connect with some of the biggest names in global health on some of the most pressing issues in global health.



APPLYING THE BUSINESS VOICE

As Focal Point, GBCHealth manages the PSD, which currently includes a coalition of 20 Advisory Group and Affiliate member companies that bring the business voice and perspective to the Global Fund Board and other Global Fund Committees.

Members of the Advisory Group represent the private sector to the Global Fund Board and serve on Global Fund committees and working groups. Advisory Group and Affiliate members provide valuable input on issues such as strategy, ethics and governance, audit and finance, procurement and quality assurance, market dynamics, health systems strengthening, innovation, and impact. Members actively work to engage private sector peers and to ensure representation of private sector views and perspectives in Global Fund deliberations.

Julie Essiam of Ecobank and Paul Schaper of Merck Sharp & Dohme currently lead the PSD as Board Member and Alternate Board Member.

SHAPING POLICY, BUILDING RELATIONSHIPS

Members of the PSD play a critical role in shaping Global Fund policies and strategies so that they are more effective and transparent.

Through Global Fund Board Meetings, delegation members get face-time with some of the leading decision-makers in global health—including heads of major aid agencies and foundations, Ministers of Health, implementing partners, technical agencies and Global Fund senior leaders.

GBCHealth works one-on-one with Advisory Group members, providing guidance on how to strengthen partnerships with the Global Fund and insights on potential entry points for collaboration.
